OUR AFTER-SCHOOL PROGRAM SERVES 54 CHILDREN IN GRADES K-8 WITH ENRICHMENT, ARTS, HEALTHY FOOD AND OUTDOOR PLAY, AND DAILY HOMEWORK HELP; FAMILIES CAN ACCESS A WIDE RANGE OF SOCIAL SUPPORTS THROUGH NECC AND ITS PARTNERS. 25 TEENAGERS PARTICIPATE ANNUALLY IN TEEN TEAM, WHICH ENGAGES THEM IN COMMUNITY SERVICE, LEADERSHIP OPPORTUNITIES AND RECREATION. 33 TEENS AGES 14-19 GAIN REAL-WORLD WORK EXPERIENCE THROUGH THE COMMUNITY PARTNERSHIP WITH SCHOOLS AND BUSINESS EMPLOYMENT TRAINING PROGRAM. THE NORTHEAST DUTCHESS TRANSIT PROGRAM, WHICH PROVIDES DAILY CURB-TO-CURB TRANSPORTATION IN SIX TOWNS, GAVE 3,200 RIDES TO 210 ELDERLY, DISABLED AND LOW-INCOME RESIDENTS. AFTER A 2 YEAR STUDY, WE BEGAN THE FRESH FOOD PANTRY, SUPPLYING PRODUCE, MILK AND EGGS TO FOUR AREA FOOD PANTRIES SERVING 120 FAMILIES. IN OUR SCHOOL DISTRICT, WHERE OVER 60% OF CHILDREN QUALIFY FOR FREE OR REDUCED PRICE LUNCH, OUR SUMMER LUNCH BOX SERVED 3,023 MEALS IN 2018. OUR TWO COMMUNITY GARDENS, ONE AT NECC AND ONE AT THE WEBUTUCK HIGH SCHOOL, PROVIDE FRESH PRODUCE AS WELL AS LEARNING OPPORTUNITIES TO HUNDREDS OF PEOPLE EACH YEAR.
